DIRECTIONS TO OUR NEW HAVEN OFFICE:

Take I-91 North or South to Exit 3. When exiting, please get in center lane as you approach the traffic light. Proceed straight onto Trumbull Street. Take 1st left onto Lincoln Street. The driveway for our patient parking is located on the left side facing "The Little Theater" located at 1 Lincoln Street.

The parking spaces for patients are marked accordingly.

** Please note that you are not able to access our parking lot from Orange Street. If using GPS, please enter address as 1 Lincoln Street.**

DIRECTIONS TO OUR HAMDEN OFFICE:

North on the Merritt Parkway: Take Exit 62 (Dixwell Avenue) and take a right off the exit. Go to your first light and take a right onto Washington Avenue. Our office is on the left hand side on the corner of School Street.

South on the Merritt Parkway: Take Exit 62 (Whitney Avenue) off the Parkway. Take a right off the exit and go to your third light and take a right onto School Street. Continue to the end of the street, our building will be on the left hand corner.

From I-91 and I-95: Take I-91 (if on I-95 get on I-91) to Exit 10. Take Exit 1. At the bottom of the exit take a left at that light and a left at your next light onto the Hartford Turnpike. At the next light take a right onto Dixwell Avenue. Go to your third light and take a right onto Washington Avenue. Our Office is on the left hand side on the corner of School Street.
